

CHOOSING AN ELECTRIC SUPPLIER

Did you know that you can shop for the company that supplies your electricity? That's right. In Connecticut, electric generation service is open to competition, so you can choose your electricity supplier based on what is most important to you.

ESCOGIENDO UN PROVEEDOR ELÉCTRICO

¿Sabía usted que puede escoger la compañía que le suministra su electricidad? Es cierto. En Connecticut la generación de electricidad está abierta a la competencia, así que usted puede escoger su proveedor de electricidad según lo que usted considere más importante.

Like shopping for any other product or service, you should be informed about the choice you will make. Some things to consider are price, additional services and whether the power is produced from clean or renewable energy sources. Use the Generation Services Charge on your electric bill to compare prices.

It is important to know that regardless of the generation supplier you choose, CL&P or UI will deliver your electricity, bill you for service and respond to power outages.

The suppliers listed below are participating in the Department of Public Utility Control (DPUC) customer referral program. Under that program, suppliers must offer to sell electricity to residential and small commercial customers at a fixed price per kWh for a period of not less than one year.

In addition to the companies listed below, there are other suppliers that are offering competitive generation rates for residential and small commercial customers. Please see the list on other side. Usted debe estar bien informado al hacer esta elección, igual que cuando compra cualquier otro producto o servicio. Algunos elementos a tener en cuenta son el precio, los servicios adicionales ofrecidos o si la electricidad es producida utilizando fuentes limpias o renovables. Utilice el cargo por servicio de generación (Generation Service Charge, o GSC) en su factura para comparar precios entre suministradores.

Es importante recalcar que independientemente del suministrador que escoja, CL&P o UI seguirá transportando su energía, enviando su factura, y respondiendo a los cortes de electricidad.

Los suministradores listados a continuación están participando en el programa regulado de referido de clientes del Department of Public Utility Control (Departamento de Control de Servicios Públicos o DPUC en sus siglas en inglés). Según este programa, los suministradores venden electricidad a clientes residenciales y pequeños comercios a un precio fijo por kWh (kilowatio por hora) por un periodo de al menos un año.
