Page 1 of 2

AVAILABLE only for controlled water heating electric service to any customer other than residential, except as noted herein. Controlled storage electric water heaters shall meet the Company's specifications. These units shall be installed and wired for control in accordance with the Company's specifications. This rate is available for solar water heating used in conjunction with a storage unit which meets the Company's specifications.

Available to residential customers where electricity supplies a portion of, but is not the sole source of, domestic hot water. Also available for centrally supplied water heating in apartment buildings.

This rate is not available for any space heating or for commercial or industrial processes.

COMBINED PUBLIC BENEFITS CHARGE:

Pursuant to Conn. Agencies Regs. § 16-245-1(a)(2)(A) the Systems Benefits Charge, the Conservation Charge, and the Renewable Energy Charge are combined for billing purposes into the Combined Public Benefits Charge effective January 31, 2006.

RATE ADJUSTMENTS: This rate will be adjusted as provided in the Company's Energy and Transmission Adjustment Clauses.

COMPETITIVE TRANSITION ASSESSMENT COST ADJUSTMENT:

Competitive Transition Assessment (CTA) charges and terms under this rate includes a CTA Cost Adjustment Charge set in accordance with the Company's CTA Cost Adjustment.

SYSTEMS BENEFITS COST ADJUSTMENT:

Systems Benefits service charges for all customers taking service under this rate shall be set in accordance with the Company's Systems Benefits Cost Adjustment.

SPECIAL PROVISIONS:

Primary Metering: If the service is metered on the primary side of the transformers supplying the customer, 2% of the metered kilowatt-hours will be deducted in computing the bill.

MINIMUM CHARGE: The minimum charge is the customer charge.

TERM OF CONTRACT: One year and thereafter unless canceled by one month's written notice.
